



CORPORATE MEMBERSHIP OFFERINGS

THE CHEZ MARGAUX CORPORATE MEMBERSHIP, TO BE SECURED UNDER A SINGULAR FORM OF PAYMENT, WOULD BE OF USE OF AND APPLY TO A LIST OF EXECUTIVES AND/ OR BUSINESS ASSOCIATES; A MINIMUM OF FIVE (5) BENEFICIARIES ARE REQUESTED TO QUALIFY FOR THE CHEZ MARGAUX CORPORATE MEMBERSHIP. ALL MEMBERS MUST BE PRE-APPROVED BY THE CHEZ MARGAUX MEMBERSHIP COMMITTEE.

THE COST FOR 5 INDIVIDUAL MEMBERSHIPS IS \$20,000 PER YEAR WITH A ONE-TIME INITIATION FEE OF \$6,250, WHICH INCLUDES A 50% DISCOUNT ON INITIATION FEES. YOU CAN INCREASE THE NUMBER OF MEMBERS AT THE COST OF \$4,000/YEAR AND \$1,250 INITIATION PER MEMBERSHIP. A SALES TAX OF 8.875% AND 3.6% CREDIT CARD FEE WILL BE ADDED TO THE ANNUAL AND INITIATION FEES.

IN ADDITION, YOU WILL HAVE THE RIGHT TO CHANGE THEIR LIST OF SUGGESTED MEMBERSHIP BENEFICIARIES UP TO TWO (2) TIMES A YEAR, WITH A 30-DAY ADVANCE NOTICE, AS WELL AS THE ABILITY TO SET UP A HOUSE ACCOUNT AT CHEZ MARGAUX WITH A COMPANY'S CREDIT CARD ON FILE THAT WILL BE CHARGED & COLLECTED MONTHLY FOR YOUR CORPORATE MEMBERS' F/B EXPENDITURES AT CHEZ MARGAUX.
